of 1st Quarter Fiscal Year 2018/19

With the completion of Fiscal Year 2017/18 on June 30, 2018, the Finance Department has been diligently working on the year end process to complete the audit of the annual finances. Final numbers will be available after the completion of the audit, but preliminary numbers indicate the year end numbers are slightly better than projected with the approval of the budget on June 25, 2018. Preliminary Measure H revenues finished slightly more than projected and expenditures were slightly below the July projection.

The first quarter of fiscal year 2018/19 ended on September 30. Due to the lag in sales tax receipts, we have only received approximately \$232,500 or 7.3% of the budgeted revenues, consistent with last budget year. Our expenditures to date are approximately 2% under budget with actual expenditures approximately \$722,000 or 23% of the \$3.3M approved Measure H budget.

Staff will make a brief presentation and seek any direction that Oversight Committee wishes to provide.
