



## **CITY COUNCIL APPOINTED BOARD, COMMISSION, AND COMMITTEE VACANCIES IN 2017**

Notice is hereby given that the City of Ceres encourages residents to apply for positions on City Boards, Commissions and Committees that will have vacancies in 2017.

At the end of each year the City posts a list of expiring appointed terms for the coming year, names of incumbents, and the dates of their appointment. Citizens wishing to serve on Boards, Commissions or Committees may request information or pick up an application for appointment consideration in the office of the City Clerk, 2720 Second Street, phone 538-5755. The following is a complete list for 2016/2017.

### **PLANNING COMMISSION** (4-year term)

This commission acts as a quasi-judicial board for land use management such as zone changes, appeals and long-range community development planning. In order to be eligible for appointment to the City Planning Commission one must be a resident of the City of Ceres, and if a City Planning Commission member moves his place of residency from the City of Ceres, it shall be considered an automatic termination of that person's position as a Planning Commission member. Meetings are held the first and third Mondays of each month at 6:00 p.m. in the City Council Chambers and last approximately two hours.

### **MEASURE H OVERSIGHT COMMITTEE** (3-year term)

Section 3.10.160 of the Ceres Municipal Code established a Citizen's Oversight Committee to monitor the expenditure of revenue collected from the Measure H sales tax and report to the citizenry and the City Council. The committee consists of five (5) members appointed by the City Council. No member may serve more than two consecutive three-year terms. The committee meets no less than two times per year on an as needed basis.
