

# GUIDELINES

All goal frames are City equipment and are not to be removed from soccer fields.

All trash cans and stakes holding down goal netting shall be removed at completion of play. (trash cans shall be moved back onto concrete sidewalk area) Any stakes left on soccer fields can cause loss of deposit.

No vehicles are permitted in any soccer field area without prior approval from Parks Director. Alcoholic Beverages are prohibited in all City Parks. Hours may vary throughout the year. No sale of food products, drinks, etc. shall be permitted by any group except City of Ceres and Ceres Youth Soccer.

All fields lining is to be completed by The City of Ceres "only". Fields are mowed Mon., Wed., and Fri. by 3:00PM with weather permitting.

Parks can be closed for unforeseen maintenance problems and will be re-opened as soon as possible.



## **Rules & Guidelines**

### **Insurance**

All renters of soccer fields complex for tournaments and league play will provide the City with an insurance endorsement naming the City as an additional insured for \$1 million dollars of liability insurance when using the fields.

### **Cancellations**

There are NO FACILITY/FIELD REFUNDS, CREDITS OR CHANGES IN SCHEDULE. When an activity is cancelled, no rescheduled activity will be allowed without first notifying Recreation Department.

All persons wishing to reserve Ceres River Bluff Regional Park must be at least 18 years of age. A reservation form must be completed and approved prior to use of the facility.

All trash shall be picked up in the park field areas. Persons not leaving the fields in a neat and clean condition shall forfeit their right to reserve the fields in the future and a fee for cleaning will be deducted from the deposit.
