November 26, 2007

Mayor Cannella called the City Council Meeting of November 26, 2007 to order at 7:00 p.m. with the following in attendance:

Kevin Fliflet, President of the Ceres Youth Commission gave a brief report on the activities of the Youth Commission including recent park openings, the Fire Station 4 ribbon cutting, the Halloween Festival in Smyrna Park and the upcoming opening of Christmas Tree Lane.

Doug Lemcke, Recreation Director, introduced the item requesting an increase in the pergame salary for soccer officials who officiate games solo.

Vice Mayor Phipps asked if the teams were comfortable playing with only one official.

Mr. Lemcke responded that the teams are given the option of canceling or playing the game with one official. Most teams prefer to continue playing.

Councilmember Vierra asked why staff is recommending retroactive pay to August, 2007.

Mr. Lemcke responded that in order to entice the officials to continue working solo, staff told them they would request retroactive pay from the beginning of the season.

13. Ordinance No. 2007-978 amending Title 9 of the Ceres Municipal Code to prohibit underage drinking and assess liability for those who knowingly host gatherings where minors consume alcohol. (First Reading and Introduction)

Mike Lyions, City Attorney, introduced the item stating that at its meeting of August 13, 2007, the City Council considered the second reading and adoption of Ordinance No. 2007-973 which addressed the problems generated by social gatherings at private residences and commercial or business premises where minors consume alcoholic beverages. The original ordinance contained provisions which allowed the recovery of public safety costs incurred by the City when responding to such gatherings and allowed administrative civil citations in lieu of criminal prosecution for persons violating the ordinance.

At its meeting of August 13, 2007, the City Council rejected the adoption of the proposed ordinance and directed the City Attorney to bring back an ordinance which eliminated the recovery of cost provisions, removed the civil fine provisions and limited enforcement to formal misdemeanor criminal prosecution of persons who violate the ordinance thereby preserving the right of those charged with a violation of the ordinance to demand a jury trial.

This ordinance as presented removes the objectionable portions of the previously proposed ordinance; but retains as misdemeanor criminal offense, a provision which prohibits persons having control of any premises from knowingly hosting, permitting, or allowing a gathering where a minor consumes an alcoholic beverage.

Adolph Estrada, resident, asked if the subject responsible for serving alcohol would be issued a citation or arrested and what is the outcome based on.

Mike Lyions, City Attorney, responded that it would be the discretionary call of the arresting officer whether the subject would be arrested or cited.

Art de Werk, Public Safety Director, responded that there generally a person is subject to booking if there are any number of variables present. For example: if the person is excessively intoxicated, or if there is a likelihood of reoccurrence, or if there is an outstanding warrant, or if they have failed to appear on some previous arrest matter. The word discretion is applicable but it really is more a matter of the interpretation of what the officer believes is present at the time of the crime.

NEW BUSINESS

14. **Resolution No. 2007-226** accepting and approving the compensation and classification report and **Resolution No. 2007-227** approving appropriation adjustments for the implementation of said report.

Brad Kilger, City Manager, introduced the item and outlined the steps leading up to the study. The last Compensation and Classification study was completed over sixteen years ago. Since that time, the City's compensation plan has not kept up with the market causing Ceres to loose valuable employees to surrounding communities and making it difficult to recruit qualified personnel. Mr. Kilger further explained that the recommendations for implementation outlined in the report would place staff salaries at the median of the market.

Doug Johnson, representing Johnson and Associates presented to Council the methodology used to gather data for the Classification and Compensation Study and the results of that data.

Sarah Ragsdale, Administrative Services Director, briefly outlined the fiscal impact and risk assessment should Council implement the compensation per staff's recommendation. Staff recommended an implementation plan that would be effective for the first pay period beginning after Council review and approval of the Study. For FY 2007/08, the adjustments would not exceed 16% of an employee's current salary; any remaining increases will be given on July 1, 2008.

Mayor Cannella and Councilmember Vierra expressed concerns with the cost to the General Fund with an uncertain economy as well as a concern for the compensation recommendation for a few of the positions. Mayor Cannella suggested making the following adjustments to the recommended salary ranges: Adjust the Finance Mgr., IT Mgr., HR Mgr., Redev./Econ. Development Mgr. and Planning Mgr. positions from range 82 - 80; City Clerk from range 78 - 76; Engineering Tech I/II-I from 51 - 50, Engineer I/II-II from 55 - 55; Facilities Supervisor from 59 – 58.

Mayor Cannella also suggested that the salary increases be implemented over the next three years with 10% beginning now, 10% in one year, if approved and the remainder the next year, if approved.

After extensive Council discussion on various issues including staff turnover and its effect on City services and projects, the City's ability to recruit personnel, implementation schedule, the City's ability to fund the increases, the following motion was made:
