# **January 9, 2012**

Bryan Briggs, Economic Development/Redevelopment Manager, presented the staff report to Council stating that AB 26, which was signed by the Governor of California on June 29, 2011, added Parts 1.8 and 1.85 to the Community Redevelopment Law. Part 1.8 immediately suspended most redevelopment agency activities. Part 1.85 provides that on October 1, 2011 (extended to February 1, 2012 by the Court), all existing redevelopment agencies and redevelopment agency components of community development agencies are dissolved, and successor agencies are designated as successor entities to the former redevelopment agencies. Except for those provisions of the Redevelopment Law that are repealed, restricted, or revised pursuant to AB 26, all authority rights, powers, duties and obligations previously vested with the former redevelopment agencies under the Redevelopment Law are vested in the successor agencies.

To avoid any uncertainty of account of ambiguous provisions of AB 26, staff recommends the City Council serve as the successor agency to the Redevelopment Agency. Mr. Briggs stated that there may be some benefit to serving as the successor agency because the City of Ceres will implement the

wind-down of the redevelopment agency and have some control over that process, albeit under the supervision of an oversight board.

After some discussion, Council felt strongly about acting as the successor agency to the Redevelopment Agency however not all Council members felt the City should act as the successor agency to the SCRC since most of the area is in the County's jurisdiction.
